I wish to gain your full cooperation to fulfill my objectives and goals as Secretary General of the APT.

Distinguished Delegates, Ladies and Gentlemen,

The Asia-Pacific Telecommunication and ICT Development Forum or the so-called ADF is one of the key activities of the APT to address telecommunications and ICT development issues for developing countries. It is the platform where policy makers, regulators and other relevant officials discuss and share information on the best practices and experiences on ICT Development issues.

This is the first ADF meeting since the APT held the Ministerial Meeting in Brunei Darussalam last September. I strongly believe that through this kind of practical activity, the APT can closely assist our Members in achieving concrete outcomes and have real impact to the development of the telecommunication / ICT sector in the region.

Ladies and Gentlemen,

Despite the rapid development of ICT in Asia-Pacific, there are still gaps in the ICT accessibility and affordability in developing countries especially in LDCs and SIDS. To deal with these challenges, efforts have been made in order to facilitate investment for the establishment of sustainable ICT infrastructure in unprofitable areas. Different investment models such as Public-Private-Partnership, Government-led initiatives, Projects funded by donors, Infrastructure Sharing model are suitable for different environments. Moreover, other crucial factors of the project lie in funding and efficient project management.

At this ADF, we are pleased to have experts from the World Bank and United Nations Office of Project Services (UNPOS) who kindly agree to share information on the available funding scheme and the ICT infrastructure project management. I very much hope that you can find these presentations useful and could make use of the opportunity to network and discuss with the experts for further collaborations.

Distinguished Delegates,

The Agenda for ADF this year includes topics of concern for developing countries allowing Members to share best practices and experiences in ICT development as part of the APT's efforts in assisting our members for a sustainable development through ICT.

Regarding the conducting of the Forum, unfortunately, Mr. Mohamed Giashuddin Ahmed from Bangladesh, the Chairman of the ADF and Mr. Takamichi Kajiwara from Japan, the Vice-Chairman of the ADF are unable to be with us here. Therefore, there will be an election of office bearers to conduct the meeting right after the opening session. I hereby request your full support in nominating Chairman and Vice-Chairmen of the ADF to perform these important duties.

Ladies and Gentlemen,

Government has key roles in driving the ICT development, adopting ICT to improve efficiencies in providing public services to citizens, lowering the cost of network access, providing incentives to private sectors to develop innovative applications, facilitating and nurturing new ICT entrepreneur and start-ups, to name a few. It is important that the ICT services should be accessible to everyone at affordable cost on equitable basis. The potential of digital economy should be fully exploited to realise the transformational impact of digital technologies on the economy and societal well-being of our people.
