Distinguished Delegates,

I would like to congratulate and welcome new Chairman and Vice Chairmen of AWG who were elected at the 17<sup>th</sup> meeting of AWG in September 2014 at Macao, China.

AWG provides the platform to discuss and share information on emerging radio technologies, stimulate research and development, and promote related telecommunication business within the Asia-Pacific region. AWG also provides regular channels to discuss and study spectrum sharing methodologies, spectrum harmonization and to provide advice that countries can use in frequency band planning.

Since the launch of this AWG (which was called AWF in the past), there are several recommendations and reports being developed. Several reports have been revised recently as needed and some reports are still under development. At AWG-17, the Ad-hoc group was established to undertake several key studies including review of objectives, terms of reference and working methods of the Group to cope with rapidly increasing development of radiocommunication technology and spectrum demands for radiocommunication services in Asia-Pacific region. I anticipate that with the ITU World Radio Conference being held in late this year, the issues on radiocommunication technologies, services and spectrum being discussed at AWG has grown tremendously in recent AWG activities. I understand that AWG has conducted studies on a number of WRC-15 Agenda Items in response to liaison statements from the APT Preparatory Group (APG). This illustrates the recognized capability and expertise of the experts available in AWG. I sincerely believe that the result of these studies will effectively help APG and APT Members to reach a consensus on development of APT Common Proposals and a number of important issues for the upcoming WRC-15.

Ladies and Gentlemen.
