# APT Preparatory Group for WTDC

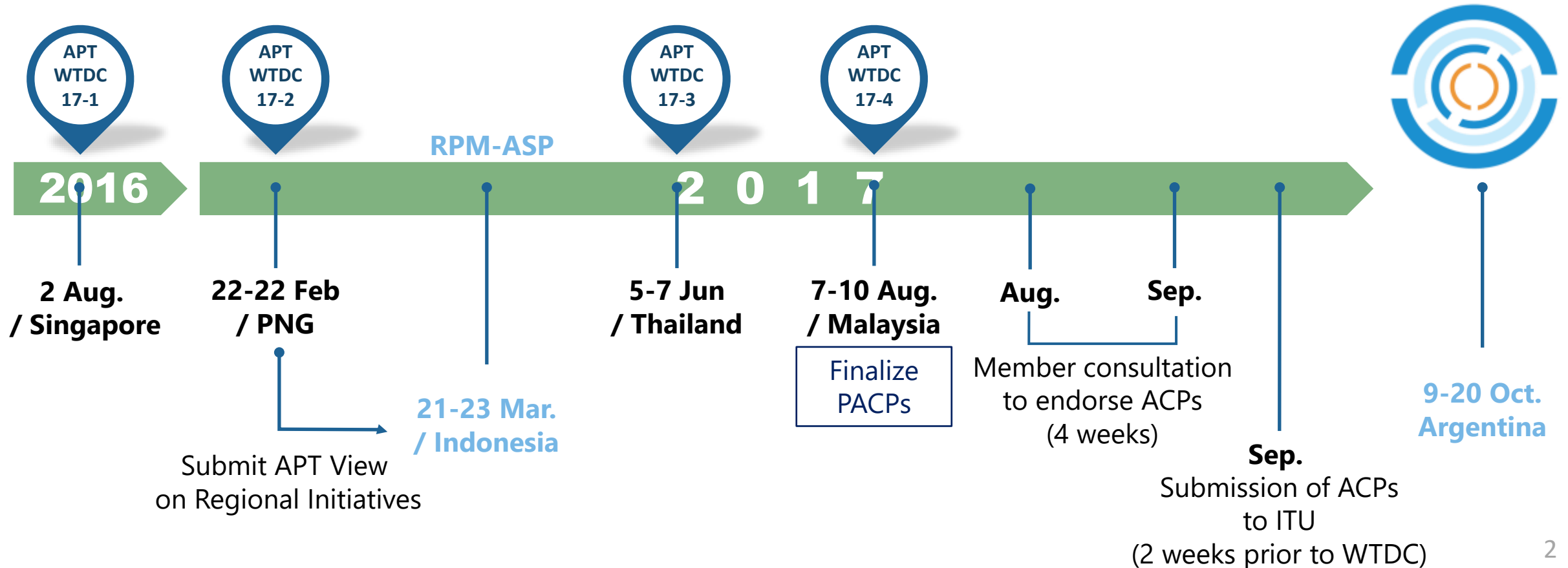
## ✔ Objectives

- ✔ To assist APT Members to prepare for the World Telecommunication Development Conference in coordinating issues of regional interest and the submission of regional contributions to the Conference;
- ✔ To develop proposals from APT Members that considers the interest of the Asia-Pacific region as inputs for WTDCs;
- ✔ To develop inputs from APT Members for ITU Regional Preparatory Meeting (RPM) for Asia and the Pacific;
- ✔ To assist APT Members during the WTDC.



# Work Plan at APT WTDC-17

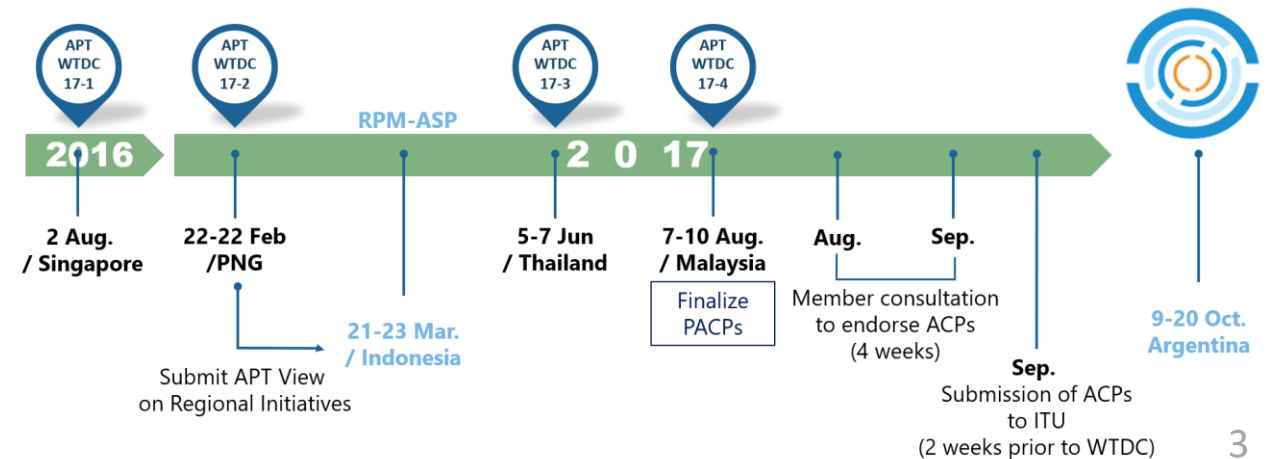
✓ 4 times of Preparatory meetings were arranged





# Lessons learnt from APT WTDC-17 Work Plan

- ✓ APT played a key role in drafting Regional Initiatives at WTDC17-2, which submitted to RPM-ASP as an APT View
- ✓ 40 per cent of total PACPs were concluded at the WTDC17-3 which were reaffirmed at the WTDC17-4
- ✓ It is strongly recommended to submit contributions by 3rd Preparatory meeting so that members may have ample time for the due considerations

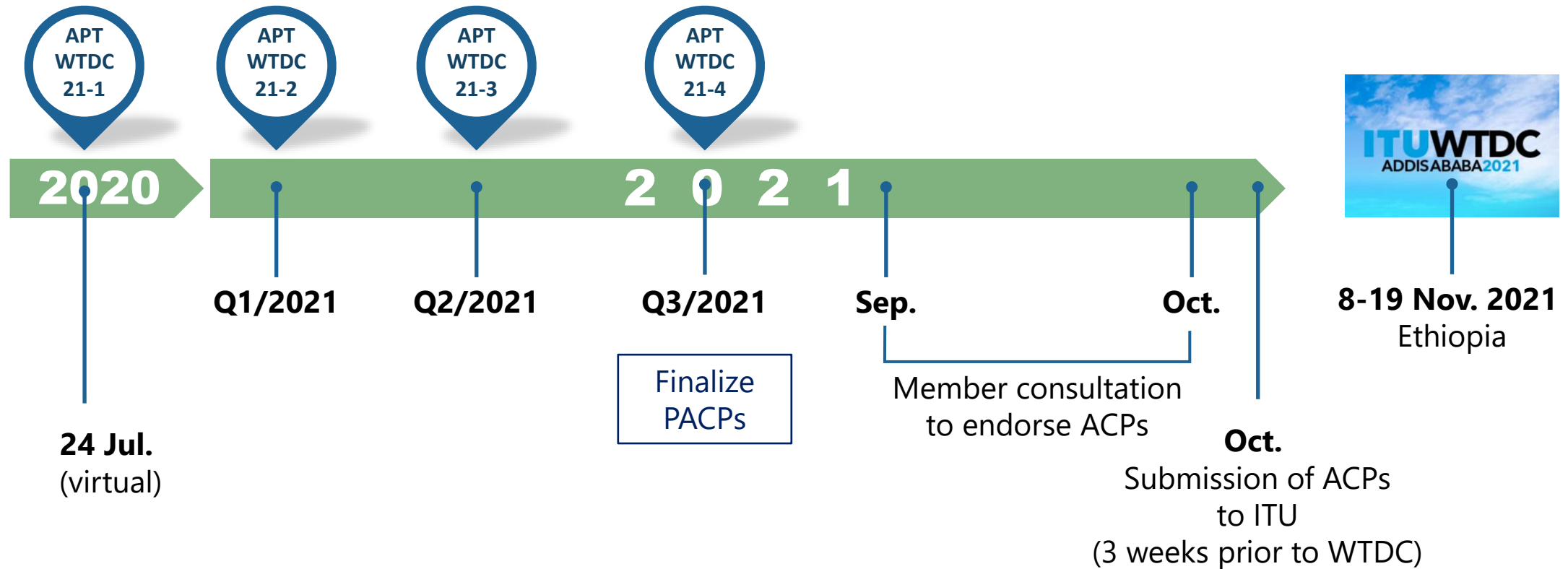

# Deliverables of APT-WTDC

## ✓ **APT Common Proposal (ACP)**

A document containing subject matter developed by APT WTDC-21 and endorsed by the required number of APT Members for submission by the Secretary General as a multi-country proposal to another organization

*Note: Member consultation is required*

## ✓ **APT Position**

A document containing an agreed view of APT Members on certain matters to be used internally prior to or during the debate at international Conferences/Assemblies

*Note: Plenary approval is required*

## ✓ **APT View**

A view approved by the plenary of the WP on certain matters, which can be submitted to an international organization by the Secretary General on behalf of Members participating at that plenary

*Note: Plenary approval is required*
