Subject: Virtual Meeting for the 1st Meeting of the APT Conference Preparatory Group for WRC-23 24 - 25 September 2020

I am pleased to inform you that the Asia-Pacific Telecommunity (APT) will organize a virtual meeting for the 1st Meeting of the APT Conference Preparatory Group for World Radiocommunication Conference 2023 (APG23-1) from 24 to 25 September 2020.

Considering the ongoing COVID-19 pandemic, APT Secretariat had consulted with the Chairman of the APT Conference Preparatory Group for WRC-19 and Special Senior Advisor to the APG, and it is decided that the APG23-1 will be organized virtually.

The objective of the APG23-1 is to initiate the preparatory process of the APT for the World Radiocommunication Conference 2023 (WRC-23) and Radiocommunication Assembly 2023 (RA-23). The APG23-1 is expected to:
