

20th APT Policy and Regulatory Forum (PRF-20)

Virtual Meeting, 20 - 22 October 2020

CONCEPT NOTE

1. Background/Context

APT has created the Policy and Regulatory Forum (PRF) as a platform to share and exchange valuable views and experience on issues which are to our common concern, with the aim of achieving a more harmonized regulatory environment in the region. It is also a platform for the industry to bring issues of their concerns to the attention of the regulators. In almost two decades, the APT PRF has been regarded as a high-level event that underlines the important role of the APT in shaping key ICT policies in the Asia-Pacific region.

The Strategic Plan of the APT for 2018-2020 provides guidelines for the activities of the APT and this year is the last year for the current implementation period while each Work Programme still need to focus its work within the five Strategic Pillars i.e. Connectivity, Innovation, Trust, Capacity Building, and Partnership. The outcomes of the implementation of Strategic Plan for the current period will be reported to the 15th Session of the General Assembly of the APT at the end of this year.

While PRF has a successful record as a discussion platform and the 43rd Session of the Management Committee of the APT approved to organize the 20th APT Policy and Regulatory Forum (PRF-20) in 2020, the COVID-19 pandemic imposed restrictions on international travelling in many countries and it is very difficult to organize a physical meeting for PRF-20. The APT Secretariat in consultation with the Office Bearers of the PRF decided to organize a virtual meeting for the PRF-20.

The PRF-20 aims at addressing hot policy and regulatory issues of ICT in the region while also focus on the five Strategic Pillars of the Strategic Plan of the APT. During the COVID-19 pandemic, ICT has shown its important role to combat this crisis and how it can be enabler in other sectors. The PRF-20 will address issues related to the COVID-19 pandemic in relation to connectivity, innovation, and trust Pillars. Policy makers and regulators will share experience on the lesson learned from this outbreak as well as deliberate on policy and regulatory measures for post-COVID-19 era. Industry representative will share its contributions in coping with COVID-19 outbreak and to discuss the policy and regulatory considerations for post-COVID-19 era.

The forum also features a session on Online Well-being and Safety which will discuss the approaches in managing misinformation which has become a major issue these days, and the pros and cons of Privacy vs Functionality by looking at the case study in contact tracing applications of COVID-19 in particular. In addition, the programme will also address new context in connectivity and provide update on 5G deployment.

2. Objectives

APT PRF provides an opportunity to share and address key issues of concern to APT Members, as well as to facilitate intra-regional collaboration on policy and regulatory issues as required. Industry leaders and other key stakeholders also share their views on major issues facing the sector.

The specific objectives for PRF-20 are to:

- Share experience on the lesson learned from the COVID-19 outbreak and to deliberate on policy and regulatory measures for post-COVID-19 era
- Provide a platform for industry to discuss and share the industry contributions in coping with COVID-19 outbreak and to discuss the policy and regulatory considerations for post-COVID-19 era.
- Enhance understanding on policies, regulations, strategies, and initiatives to address secure and trusted ICT services including issue on balancing between data protection and functionality and approach in managing misinformation.
- Understand challenges and issues in providing connectivity during the crisis, the concept of meaningful connectivity, and global connectivity with new technologies.
- Enhance understanding on 5G deployment and actions being undertaken by APT members in terms of policy and regulatory issues, national action plan, spectrum issues as well as investment strategies and models for 5G deployment

3. Expected outcomes

This time, the meeting is conducted as a virtual meeting due to the COVID-19 and number of sessions is limited for the current policy and regulatory issues including connectivity, innovation, secure and trusted ICT service. The provisional agenda and tentative programme of the PRF-20 are enclosed herewith and annexed to the concept note (See Annex A and B for more information).

Specific outcomes include but not limited to:

- Common challenges and lesson learned from the COVID-19 outbreak and policy and regulatory measure for post-COVID-19 era are identified
- Enhanced awareness of policy makers and regulators on policy and regulatory consideration for post-COVID-19 era
- Better knowledge on policies, regulations, strategies, and initiatives for balancing between data protection and functionality and approach in managing misinformation.
- Common challenges in providing connectivity during crisis are provided and understanding of the concept of meaningful connectivity and global connectivity with new technologies
- Better knowledge on 5G deployment and actions being taken by APT members

4. Timing

The virtual meeting of the PRF-20 will be a 3-day event from 20 to 22 October 2020. The meeting will be organized via Zoom meeting platform from 10:30 AM - 13:45 PM (GMT+7).

5. Participation

All APT Members, Associate Members, Affiliate Members, International/Regional Organizations, and eligible non-members can participate in the PRF-20.
