Considering the COVID-19 pandemic situation in the Asia-Pacific, APT Secretariat in consultation with the Chairman and Vice-Chairmen of the PRF considered the necessity of the virtual meeting for the PRF-20, which was also agreed by the Chairman and Vice-Chairmen of the Management Committee of the APT.
