

## SATRC Workshop on Policy, Regulation and Services

31 August - 1 September 2021, Virtual/Online Meeting

### CONCEPT NOTE

#### 1. Background

The 19th Meeting of the South Asian Telecommunication Regulators' Council (SATRC-19) held in Islamabad, Pakistan from 13 to 15 December 2018 approved the SATRC Action Plan Phase VII for the implementation period of 2019-2020. (The SATRC-21 has extended the implementation period to 2021 because of the COVID-19 pandemic.) SATRC Action Plan consists of three basic activities: working groups, capacity building and web portal. SATRC Workshops are held as part of activities under capacity building with the objective of developing the capacity of human resources of the regulators of SATRC Members.

Three work items were identified for the activities of SATRC in relation to policy, regulation and services during the implementation of SATRC Action Plan Phase VII:

- Regulatory approaches to enhance QoS of mobile operators
- Digital financial services
- Harmonizing ICT indicators in SATRC

#### 2. Objectives

The SATRC Workshop on Policy, Regulation and Services will be held as part of implementation of SATRC Action Plan Phase VII. The objective of the workshop will be to give an in-depth analysis on the work items under the SATRC Working Group on Policy, Regulation and Services in order to increase the understanding on those work items. In addition, the workshop will also cover the policy and regulatory initiatives and best practices to lead digital transformation of the economy and the society in the context of South Asia. It will give an opportunity for the SATRC Members to share their experiences and knowledge, identify bottlenecks and find solution based on collaboration to provide connectivity and online access to ICT services. A number of eminent experts and speakers will be invited to conduct the workshop.

#### **3. Expected Participation**

The SATRC Workshop on Policy, Regulation and Service will be targeted for senior and midlevel officers of the SATRC Members who are involved in the work of related areas. It is expected that the experts of the SATRC Working Groups will also attend the workshop. Further, relevant experts from industry are also welcomed to participate at the workshop.

#### 4. Expected outcomes

- Enhanced understanding of the SATRC Members on policy and regulatory issues for providing connectivity and online access to ICT services
- Enhanced cooperation among SATRC Members to address the challenging issues related to those in a collective manner
- Discussion will provide guideline to SATRC Working Group on Policy, regulation and Services to develop tangible outcomes on the work items during the implementation of SATRC Plan Phase VII.

#### 5. Timing and location

The SATRC Workshop on Policy, Regulation and Services will be held from 31 August to 1 September 2021 virtually. Details are provided in Information for Participants.

(010+7)	Growing concerns on various QoS parameters specially Call Drop, Call Quality and Data Throughput have been observed recently in many SATRC Member countries. With the increase of the subscriber base, customer's dissatisfaction is increasing and complaints against the network are also increasing. To ensure a level playing field along with a competitive environment and subscriber satisfaction, performance measurement with a common standard with regard to the QoS is a must.
	SATRC Member countries adopted 4G technology and on the way to adopt 5G. So, it is now time to set some benchmarks/ thresholds for mobile phone operators that they comply and ensure customer's satisfaction. This session will address the current regulatory measures in place in SATRC Members to ensure QoS, regional and global best practices, views from industry and find a mechanism to develop and implement common regional approaches and benchmarks to ensure QoS.
