Subject: Election of Secretary General and Deputy Secretary General of the Asia-Pacific Telecommunity at the General Assembly in 2023

I have the honour to refer to Article 8, Paragraph 6 (e) of the Constitution of the Asia-Pacific Telecommunity (APT) that the General Assembly shall elect the Secretary General and the Deputy Secretary General of the Telecommunity and define the terms and conditions of their employment.

As you are aware, the incumbent Secretary General and Deputy Secretary General were elected by the 15th Session of the General Assembly of APT held in December 2020 in Bangkok, Thailand, with the term from 9 February 2021 to 8 February 2024.

In this connection, I would like to inform you that the election of the Secretary General and the Deputy Secretary General of the APT for the next three-year term will be held during the forthcoming 16th Session of the General Assembly of the APT (GA-16), which is scheduled to be held from 6 to 7 November 2023. Therefore, Member Administrations of the APT are invited to nominate a candidate for the above-mentioned posts. The invitation letter for GA-16 will be sent to APT Members in due course.

The submission of candidature shall be in line with Annex 1 of Resolution 12 (GA-15, Bangkok, 2020, Rev.1) on "Procedures for the election of the Secretary General and the Deputy Secretary General of the Asia-Pacific Telecommunity". Please be advised that:

- Each candidature shall be accompanied by the curriculum vitae of the candidate
- The candidatures must be received by the Secretary General no later than 23.59 hours (Bangkok time) on Monday 9 October 2023, which is the twenty-eighth day prior to GA-16.
