**Subject: The Meeting of the SATRC Working Group on
Policy, Regulation and Services
14 – 16 May 2024, Islamabad, Pakistan**

The 47th Session of the Management Committee of the APT (MC-47) approved the South Asian Telecommunication Regulators' Council (SATRC) as one of the Work Programmes for 2024. I would like to inform you that the APT will organize the Meeting of the SATRC Working Group on Policy, Regulation and Services from 14 to 16 May 2024 in Islamabad, Pakistan with physical attendance as well as virtual/online participation through Zoom meeting (i.e. hybrid meeting). The Meeting will be hosted by Pakistan Telecommunication Authority (PTA).

The Meeting of SATRC Working Group on Policy, Regulation and Services is a part of the activities of SATRC Action Plan Phase IX (SAP-IX) which was adopted by the 24th Meeting of SATRC (SATRC-24) held in 2023. It will be the first meeting of the Working Group under SATRC Action Plan Phase IX and it is expected to discuss the Work Items assigned to the Working Group by the Council.

In this connection, I would like to invite your organization to consider sending your Experts to attend the meeting who have been nominated for this Working Group by your organization. The list of Experts is attached herewith for your information. The presence of the enlisted Experts in this meeting is essential for the successful implementation of SAP-IX. Such additional cost for physical attendance should be borne by either fellowship participants or their organizations.
