The programme for this year also includes a number of interesting presentations on IMT-2020, IoT, Digital Inclusion, and OTT from APT members and sharing of international experts' views on some of the new technology development and challenges for policy and regulation. In addition, the panel discussion will address on nurturing OTT business as a growth engine versus regulating OTT to level playing field. I wish to encourage all participants to contribute to the session.

I also encourage you to provide your thoughts for the preparation of the new Strategic Plan of the APT 2018-2020 when we discuss the item at the closing session.

I would also like to highlight that in the afternoon of the last day, there will be a site visit which is kindly arranged by MIC Japan, NEC and Fujitsu. I hope you find the site visit useful.
